Course Description:

This full certification course/program offers 120 hours covering all subject matter necessary to have a well-rounded practice in foot reflexology.

The course includes instruction in Anatomy and Physiology, Reflexology Theory, Business Practices and Management. There are many hours of supervised hands-on practice including clinical practice. Students will deepen their knowledge with their own research in a variety of subjects as well as viewing videos pertaining to reflexology.
